Workload of the Federal Constitutional Court Remains High

In the 65th year of its existence, the Federal Constitutional Court recorded a slight decrease in the number of new proceedings. While approximately 5,800 new proceedings were entered in the register of proceedings (approx. 5,900 in 2015), the number of new proceedings in the General Register remained, as in 2015, at approximately 8,800 new proceedings. Although this number of new proceedings is considerably lower than in 2014, which had the highest so far, the heavy workload of the Federal Constitutional Court remains unchanged. Nevertheless, the number of proceedings terminated by both Senates is once more significantly higher than the number of new proceedings entered in the register of proceedings. The number of proceedings pending before the Court could thus be reduced from 3,600 to 3,200 proceedings.

The high number of large-scale proceedings before the Senates, requiring time-consuming preparation, is the main reason for the permanently heavy workload of the Court. In the past months, both Senates have terminated several of these proceedings, such as, for example, the proceedings concerning the Federal Criminal Police Office Act, the OMT Programme of the European Central Bank and the accelerated nuclear phase-out as well as proceedings concerning the prohibition of the National Democratic Party. Other large-scale proceedings, however, are pending such as proceedings concerning the Act on Uniform Application of Collective Agreements, the newly introduced retention of data, assisted suicide and the Comprehensive Economic and Trade Agreement (CETA) between the European Union and Canada.

The citizens as well as the political players continue to hold the Federal Constitutional Court in high esteem. But the Court cannot take this for granted. Rather, the Federal Constitutional Court must work every day – by rendering clear and convincing decisions – to earn and maintain the confidence placed in it as a court for the people, but also as an arbiter in a democratic constitutional state. This holds particularly true in view of the developments in Poland,

Hungary and Turkey which show that an independent constitutional court can come under immense pressure in difficult political conditions.




